Four items were discussed: 1. Ordinance for periodic inspection of rental properties. 2. A communication tower has been contracted on Shlock Road. 3. The county has instituted a tax rebate for first responders, with a maximum amount of \$200, but not to exceed the amount of the individual's tax bill. 4.
