Road Report

Rich Marks estimates the flood damage to be about \$86,079 to repair township roads. He is documenting the flood damage repair to enable a disaster claim if available. This documentation includes taking pictures, keeping track of time sheets and load slips. Little Road will need to be tarred and chipped with an estimated cost of \$22,000. Henry Road, Old Route 220, and Gavitt Road need repairs. Fairman Road was the hardest hit, with an estimated 59 loads of stone needed in total to repair it. So far 24 loads have been used.

Other road updates:

Paving at the crossroads of Gavitt Road and Route 220 should be done by the end of August.
By direction of Penn DOT, we are waiting for stone certification before paying Midland. Midland is waiting for information from the quarry.
