A motion to purchase two new 30-yard dumpsters at a cost of \$7,150 each, for a total cost of \$14,230, plus \$630 to deliver both dumpsters was made by Leo Fiester, seconded by Jeff Hamilton, and the motion passed. The dumpsters should arrive in about six weeks.

PSATS Updates/Information: Jeff Hamilton reported that free consultation (up to \$7,500) is available for the Transfer Station if needed; provided information about options for blighted properties; and explained that townships are requested to pass a PA-250 Resolution. This resolution will be put on the agenda for the June 2, 2026 meeting.

Approve update of Quickbooks (Old software discontinued 5/31/2026). A motion was made by Rich Marks, seconded by Leo Fiester to purchase Quickbooks Enterprise Desktop at a cost of \$1,768. This will include the payroll module as well. All agreeing with the proposal, the motion passed.
