Old Business

Dollar General DEP Denial letter, township action needed – We will send a letter advising them that certain Ordinance guidelines need to be addressed, including pumping the holding tank every six months and sending proof that it has been done each time. We will also request proof that the tank is equipped with an alarm, and that employees will be trained to recognize the sounding of the alarm and how to respond if an alarm should sound.

Road Report

The Little Road project is done except for fogging. We have learned that road projects may be able to go through COG next year. Rich will find out more about the large Hellers tank which needs to be moved, and will check on permits, etc. We will send a letter if needed.
