#### **Old Business:**

**Road Report** – Rouse Road, Karge Road, Murray Road, and Mead Road have all been worked on. We are waiting for stone to continue work on Rouse Road.

### **New Business:**

Matt Conlin from PLGIT was unable to attend this meeting, but visited on Thursday, 5/18/2023 to provide information about PLGIT to the Supervisors. After a discussion today about the information provided, a motion was made by Rich Marks and seconded by Leo Fiester to do the following:

Adopt a Resolution to become a new investor in PLGIT, to complete and sign a New Investor Application, to open a PRIME account for State Funds, to open a Class account for the Regular Township Funds, and to move most funds to the PLGIT accounts when these accounts are opened. The motion carried.

Information regarding PA DOT's interest in contracting with townships to maintain state roads was set aside as not a good fit for Laporte Township.

Information was provided regarding solar contractors contacting residents. Interest was shown in addressing this issue, and we will contact PSATS for their recommendations for adopting an ordinance.

A motion was made by Rich Marks and seconded by Leo Fiester to adopt a Burn Ban Resolution to be placed in effect until July  $5^{th}$ . The motion carried.

Rick Marks requested and received permission to advertise for a truck driver. He said we may have to pay a higher rate to hire someone.

### **Adjournment**
