Hire of New Truck Driver: Due to Laporte Township losing their CDL truck driver and the difficulty in obtaining a new full-time CDL truck driver, the Township had to increase the rate of pay for this full-time position to \$21.00/hour. A driver, Kirk Hallabuk, was hired and began working July 3, 2023. This position will also include roadside mowing, snow plowing, truck repairs, and other work as needed. The part-time CDL drivers will continue to receive \$16.30/hour.

**Road Report:** The road stone is being crushed this week, and the stonework should be able to be done next week. Roadside mowing has been started.
